Procedural Order No. 7

I. BACKGROUND

- 1. On 3 March 2020, in light of the Pre-Hearing Telephone Conference scheduled on 16 March 2020 (the "PHTC"), the ICSID Secretariat sent the Parties draft Procedural Order No. 7, on the organization of the hearing scheduled between 30 March and 4 April 2020 (the "Hearing"). The Parties were invited to comment thereon and were advised that the Tribunal would discuss with them at the PHTC whether any measures needed to be taken in connection with the organization of the hearing as a result of the coronavirus outbreak.
- 2. On 11 March 2020, the Respondent requested a postponement of the Hearing. On the next day, the Claimants agreed with this request.
- On 12 March 2020, the ICSID Secretariat advised the Parties that the Hearing would be
 postponed. The Tribunal would discuss the rescheduling of the Hearing and the remaining
 procedural steps at the PHTC.
- 4. At the PHTC of 16 March 2020 and in subsequent correspondence, the Tribunal and the Parties discussed possible dates for the hearing.
- 5. On 9 April 2020, the Tribunal confirmed that the hearing would take place from 28 October to 1 November 2020, with 2 November 2020 held in reserve.
- 6. The Tribunal issues this Procedural Order No. 7 containing the revised procedural calendar.

II. DECISION

7. The arbitration shall proceed in accordance with the revised procedural calendar attached as Annex A to this Procedural Order.
