Excellency,

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Ecuador for the Promotion and Protection of Investments done at Quito on 10 May 1994 and, in accordance with the provisions of Article 12 thereof, to propose that the Agreement shall be extended to the Isle of Man, and the Bailiwicks of Guernsey and Jersey.

If this proposal is acceptable to the Government of the Republic of Ecuador, I have the honour to suggest that the present Note and Your Excellency's reply to that effect shall constitute an Agreement between the two Governments which shall enter into force on the date of your reply.

I avail myself of this opportunity to extend to Your Excellency the assurance of my highest consideration.

Tengo el honor de dirigirme a Usted en relación con su atenta comunicación de 22 de abril pasado, sobre la ampliación del Acuerdo entre el Gobierno de la República del Ecuador y el Gobierno del Reino Unido de Gran Bretaña e Irlanda del Norte para la Promoción y Protección de Inversiones, cuyo texto en español es el siguiente:
